Established in 1998, Council Services Plus, Inc., the for-profit subsidiary of CCSNYS, is a New York State licensed insurance brokerage firm that focuses exclusively on assisting and supporting nonprofits with the evaluation and implementation of employee benefits, liability insurance and risk management. This year Council Services Plus celebrates its fifth anniversary. Through its unique structure, Council Services Plus has established itself as a leader in nonprofit insurance issues and is recognized as one of the largest life and health brokerages in the Capital Region as listed in the *Capital District Business Review, 2001 Book of Lists*. In addition, Council Services Plus is licensed and serves nonprofits in Louisiana and Tennessee.

In this past year Council Services Plus increased staff and enhanced services to nonprofits by establishing "Perpendicular Billing", a benefits administration billing system that consolidates multiple group health and dental insurance programs into one bill, thus saving nonprofits time and money. In 2002, ICI staffed the following projects: Second Chance, sponsored by the Capital District Psychiatric Center; Peer-run group services sponsored by Consumers' Connection, Inc. and consumer advocacy services by the Albany County Consumer Advocacy Board for Mental Health, Inc.; and through May 2002, the Colorectal Community Outreach and the Covering Kids projects, sponsored by the Healthy Capital District Initiative.

This coming year, ICI's Board of Directors will be launching a statewide marketing effort to promote the efficiency, benefits, and cost savings of utilizing ICI to unincorporated groups and nonprofits.
